YSOP CODE OF ETHICS

YSOP adult participants are required to abide by the YSOP Code of Ethics during their participation in YSOP programs.

- YSOP youth workers and adult participants must treat people of all races, religions, cultures, genders, and sexual orientation with respect and consideration.
- YSOP youth workers and adult participants must be free of physical and psychological conditions that might adversely affect any minor's health, including, but not limited to, contagious disease.
- YSOP youth workers and adult participants will be positive role models for minors by maintaining an attitude of respect, loyalty, patience, courtesy, and maturity.
- YSOP youth workers and adult participants will do everything possible to avoid being alone with a minor other than their own.

The following behaviors are prohibited:

- smoking or using tobacco products in the presence of minors;
- using, possessing, or being under the influence of alcohol, narcotics or illegal drugs;
- sexual advances toward or sexual activities of any kind with a minor(s) or with an adult(s);
- physical abuse or bodily injury to anyone;
- physical neglect of a minor, including failure to provide adequate supervision in YSOP activities;
- mental or emotional abuse or injury to anyone;
- the presence or possession of obscene or pornographic materials at any YSOP function;
- the use or toleration of profanity in the presence of minors.

I understand that any violation of this code may be grounds for removal as a YSOP adult participant in a YSOP program with minors.
